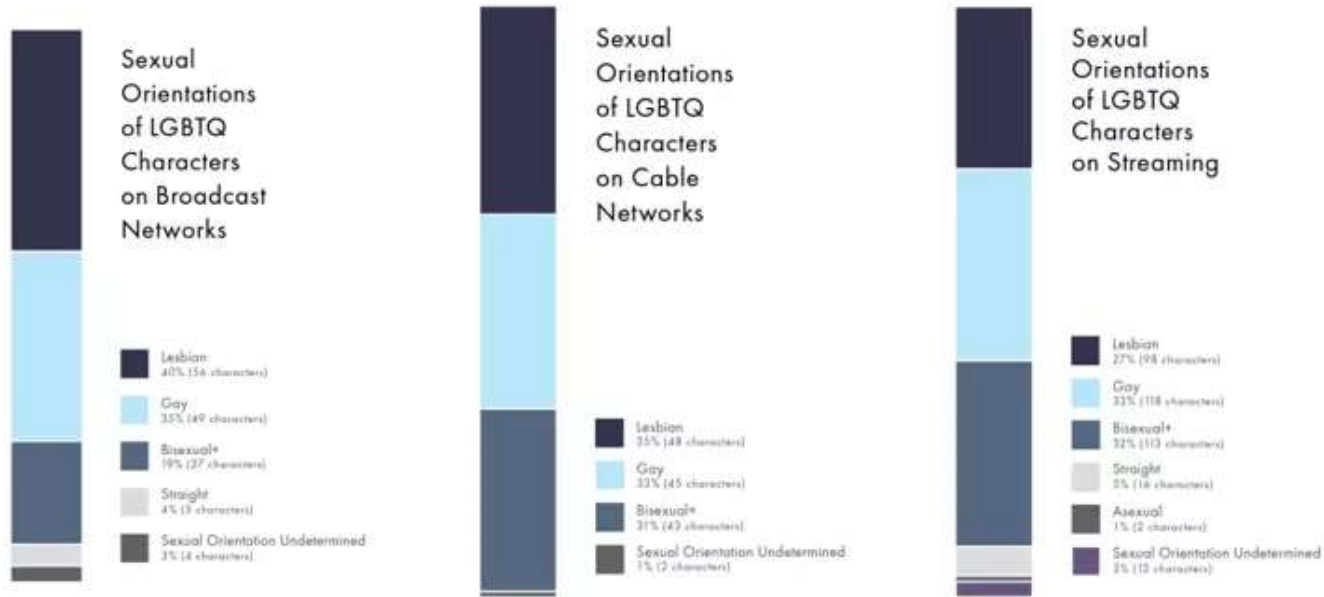

# Why we are important!

## KEY TAKEAWAYS

- 1 Forty-two percent of LGBTQ youth—and 52 percent of trans youth—said they seriously considered suicide in 2021. Attempted suicide rates also are higher for Black and Indigenous students, according to data from The Trevor Project.
- 2 Students said the proliferation of anti-LGBTQ bills, like the "Don't Say Gay" law in Florida, are intensifying their mental-health issues. This legislation has been strongly opposed by NEA and its affiliates.
- 3 There are ways for educators to help: LGBTQ students need supportive adults who use affirming words. They need access to safe spaces and events. And they need to see themselves, positively, in curriculum.

A 2021 Gallup poll found that [7.1% of the US](#) identifies as lesbian, gay, bisexual or transgender – double the percentage in 2012 when Gallup started measuring the community. Perhaps even more importantly, one in five Gen Z members (21%) now identify as lesbian, gay, bisexual, or transgender and this percentage has nearly doubled in just 5 years.



Lesbian, gay, bisexual and transgender people make up an estimated [4.5 percent of the U.S. population](#), and, according to Nielsen's inaugural report, they were 6.7 percent of the top 10 recurring cast members in the top 300 programs on broadcast, cable and streaming platforms in 2019. The report also found that 26 percent of the top 300 programs included at least one cast member who identifies as LGBTQ.

While the numbers alone paint a picture of increased visibility, Stacie de Armas, Nielsen's senior vice president for diverse consumer insights, said it's important to differentiate presence from representation.

"When you look across the TV landscape, the LGBTQ population looks well represented," de Armas told NBC News. "But when we look deeper, and at intersectional groups, it's clear there is a need for greater diversity in LGBTQ representation. White LGBTQ people
